1. Information on how to enter and prizes form part of these Terms and Conditions of Entry. Entry into this promotion deems acceptance of these Terms and Conditions of Entry.
2. The Promotion is a promotion for Farmlands Real Estate, where eligible entrants may win one of 10 \$1500 Bunnings Vouchers ("**Promotion**").
3. The Promotion begins at 12.01 am on 1 August 2018 and ends at 11.59 pm on 31 December 2018 ("**Promotion Period**").
4. The Promotion is offered by Farmlands Co-operative Society Limited of 535 Wairakei Road, Burnside, Christchurch 8053, New Zealand ("**Promoter**").

### METHOD OF ENTRY, ELIGIBILITY

5. The Promotion is open to New Zealand residents who are 18 years of age or older and who are new or existing Farmlands Real Estate customers. A Farmlands Real Estate customer means the vendor of a property who has a signed contract with Farmlands Real Estate for the listing of that property for sale ("**Customer**").
6. Employees of Farmlands who are Shareholders of Farmlands Co-operative Society Limited are eligible to participate in this Promotion so long as all other eligibility criteria is satisfied.
7. The Customer must sell a property with Farmlands Real Estate during the Promotion Period in order to be eligible to enter the draw. The property is deemed to be sold when the Agreement for Sale and Purchase of the property becomes unconditional and the deposit, if applicable, becomes payable ("**Qualifying Sale**").
8. Entry into the Promotion will be automatic upon the completion of the Customer's Qualifying Sale.
